Hi folks,

My impatience is showing, we should have waited two more hours to send you this morning's update, but I said you would know when we know, so here it is.

For the last month, we have been working to set up a vaccination clinic onsite at your community. We had hoped to be able to get you solid information prior to the State fixed site signups last Friday, but as you know, that did not happen. However, yesterday we were contacted by CVS and it turns out that our endless harassing, needling, and unending persistence has paid off. **We now have dates:**

COMMUNITY	FIRST VACCINE DATE	SECOND VACCINE DATE
RiverWoods Exeter	February 3	February 24
Birch Hill	February 9	March 2
RiverWoods Durham	February 12	March 5

These are the **only** dates they will be here for the Independent Living clinics, so if you are unable to be there for either date, please schedule through the State portal. Wherever you receive your first dose is where you must receive your second dose, so if you have already scheduled with the State and it is before the above date for your community, you may keep your appointment, or cancel and get the vaccine here onsite, but you cannot get one dose elsewhere and your second dose here.

Please complete the attached form to let us know of your vaccination plans and return to the Front Desk by **tomorrow, January 30th.**

Once we have received your form back, we will provide you with the required paperwork from CVS that we will need you to complete if you plan on getting the vaccine at your community.

Honestly, this is the best news we've had in weeks; we couldn't be more excited to make this happen for you. Science is catching up, and now CVS is too! Based on our clinic dates we should all be fully vaccinated and at full immunity by March 19. That's some damn good news! We may have to delay our St. Patrick's Day green beer celebration a few days...but better things are ahead!

Please fill out the attached form ASAP. We need to give CVS an accurate count, and we don't want anything to slow down the train! Your Executive Director will get you more information about when and where you will receive your shot. Give them a few days work out the details once we know who will participate, there is some planning and scheduling to do. We will need you to be flexible and (if you can) patient. More to come.
